1. These seats will be filled **against Self-Financed Category** and will be open to candidates from all over India.
2. For SFC seats, **reservation policy is not applicable.**
3. The candidates desirous of seeking admission in B.V.Sc. & AH and other UG programmes under **Self-Financed Category** for the academic session 2024-25 shall be based on merit of marks obtained in the following Test conducted by National Testing Agency (NTA) fulfilling the eligibility criteria of the University

4. Indian Nationals who have attained **16 years** of age as on **31st August, 2024** [for B.Sc. (Hons.) Agriculture/Horticulture/ Forestry, B.Tech. (Food Tech./ Agril. Engg.) & B.F.Sc. programmes] and minimum age of **17 years** of age as **on or before 31st December, 2024** (for B.V.Sc. & AH programme) are eligible to apply. No relaxation is permissible regarding the minimum age limit.
5. The admission fee for 1st Year; 1st Semester (for all the degree programmes) will be **Rs. 57,940/- (Rupees fifty seven thousand nine hundred forty)** only (including **tuition fee** of

Rs. 50,000/-) and from the 2nd Semester onwards, it will be Rs. 56,740/- (Rupees fifty six thousand seven hundred forty) only.

However, for B.V.Sc. & AH candidates, admission fee for 1st Year will be Rs. 2,62,180/- (Rupees two lakh sixty two thousand one hundred eighty) only per year/annum (including tuition fee of Rs. 2,50,000/- per year/annum) and from 2nd Year and subsequent years onwards, it will be Rs. 2,60,480/- (Rupees two lakh sixty thousand four hundred eighty) only per year/annum.

6. The students admitted under Self-Financed Category shall not be eligible for any financial benefits such as scholarships and any other grants from the University. However, all other facilities will be provided at par with the other State/ICAR nominees.
7. Any additional vacancy that may arise in any degree programme to be filled up from this category shall be at the discretion of the Selection Committee and subsequent approval of the competent authority.

Step – 1: Fill in the **Online Application Form** and **note down the system generated Application No.**


Step – 2: Upload scanned images of Candidate's Photograph (between 10KB – 150KB), Candidate's signature (between 10KB -- 150KB) in **JPG/JPEG/PNG format** and NEET/CUET Score Card between 50KB to 300KB in **PDF format** only.

Step – 3: After filling the form, make payment of fee using **Online Payment Method** and keep proof of fee paid

Step – 4: Print a copy of **Confirmation Page** after successful remittance of fee.

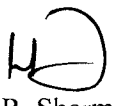
