Sir,

In the process of streamlining the admissions and to bring meritorious students to the AYUSH systems of medicine in the country, the Ministry had directed all State/ Union Territory Government to admit students in AYUSH Under Graduate Courses through the merit list of National Eligibility cum Entrance Test (NEET).

2. In this regard, attention is drawn to the Notification, issued by the Nation Test Agency, an Autonomous Organization under the Department of Higher Education, Ministry of Human Resource Development, Govt. of India for National Eligibility cum Entrance Test (UG)-2019 [NEET (UG)-2019]. Further, it has been mentioned in the information Bulletin at point no.5 of Chapter .7 that *“Use of result of NEET (UG)- 2019 by other organisations. The result of the NEET (UG)- 2019 may be utilized by other entities of Central / State Governments for admission purpose in accordance with their rules.”*

3. In this regard, all State/ UT Government are requested to make wider publicity to the students seeking admission in AYUSH-UG Courses, namely BAMS, BUMS, BHMS, BSMS and BNYS to appear in the **National Eligibility cum Entrance Test (UG)-2019 [NEET (UG)-2019]** be conducted by **National Test Agency on 05th May, 2019 (Sunday)**.

4. In view of the above, all State Government are requested for strict compliance of the instruction of the Ministry and accordingly ensure that admission of students in AYUSH-Under Graduate Courses shall be mandatorily through the merit list of National Eligibility cum Entrance Test (UG) [NEET (UG)-2019] for the academic year 2019-20.
